**REGULAR SESSION 7:00 p.m.**

**I. CALL TO ORDER AND ANNOUNCE A QUORUM PRESENT:**

Mayor Dave Shuck called the meeting to order at 7:08 p.m. Town Council members present were Alderman J. Eric Newton, Alderman Andy Goin, and Mayor Pro-Time Michael Jordan, being a quorum. Alderman Steve Miller and Alderman Darren Vader were absent due to travel.

Philip Mack Furlow led invocation.

**IV. OPEN FORUM:**

There were no further requests to address the Town Council. Alderman Newton motioned to closed Open Forum; Alderman Goin seconded. Motion carried: 4 in favor, 0 opposed.

Public Safety Committee – Alderman Newton reported that the committee was working on getting an ordinance relating to restrictions of sex offenders residing in the area and that it was a work in progress. Also reported that they were obtaining quotes for child DNA kits since there are so many children in the area and reported that the Town was one of the finalize in the Denton County Emergency Preparedness Summit and that they were still working on logistics.

Mayor Shuck reported that the Planning and Zoning Committee met for the first time.

Mayor Pro-Tem Jordan motioned to approve the Preliminary Plat of Harbor Village at Providence Phase 6C with the Planning & Zoning Commission's contingency relating to resolution of water and sanitary issues before final plat approval; Alderman Goin seconded. Motion carried: 4 in favor, 0 opposed.

- b. Consider, discuss and act upon resolution approving the "Draft" Denco Area 9-1-1 District Fiscal Year 2016 Financial Plan.

Alderman Goin motioned to approve the resolution approving the "Draft" Denco Area 9-1-1 District Fiscal Year 2016 Financial Plan; Mayor Pro-Tem Jordan seconded. Motion carried: 4 in favor, 0 opposed.

- c. Consider, discuss and act upon resolutions approving account signatories for all banking accounts with Ciera Bank.

Alderman Goin motioned to approve resolution approving account signatories for all Ciera Bank accounts; Alderman Newton seconded. Motion carried: 4 in favor, 0 opposed.

Mayor Shuck closed Executive Session and reconvened into Town Council Regular Session at 8:34 p.m.

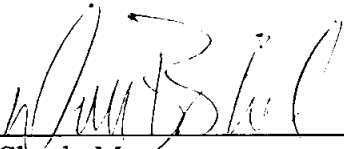

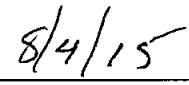
**IX. ADJOURNMENT**

Alderman Newton motioned to adjourn; Mayor Pro-Tem Jordan seconded. Motion carried: 4 in favor, 0 opposed.

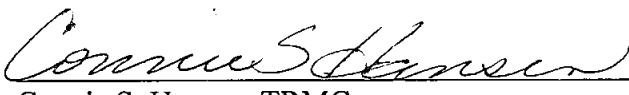

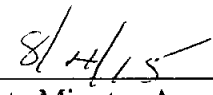
